**TIME:** Weigh-ins are the night before you lift from 5-6PM or the day of from 7:30-8:30AM, a basic rules clinic will take place at 1:30, Session 2 start time 2:00-2:10PM or 15 minutes after the completion of the Women's Nationals. Please look over the rules at RULE BOOK because we will not have a full rules clinic.

ENTRY FEE: Fees are \$100.00 for the first division or event, \$60.00 for any additional division or event.
